ORDER FOR JUDGMENT

Defendant.

The above entitled matter came on for hearing before the undersigned, one of the Judges of the above named Court on the 18th day of August, 1936, at ten o'clock in the forenoon; It appearing that due service of the summons and complaint had been made on the defendant and that she was in default for want of answer or other appearance.

Floyd N. Warner, Esquire appeared as attorney for plaintiff; On the evidence taken and on all the files and proceedings herein, the Court makes the following:

FINDINGS OF FACT.

That plaintiff's true and correct name is Dennis D. McCoy and he is forty-six (46) years of age; that the true and correct name of the defendant is Dorothy Frees McCoy and she is twenty-eight (28) years of age; that the plaintiff and defendant were married on the 27th day of November, 1933 in the City of Milbank, South Dakota; that there is no issue of said marriage; that plaintiff is a resident of the State of Minnesota and has resided therein continuously for more than one year immediately preceding the commencement of this action and the filing of the complaint herein; that during the time the plaintiff and defendant lived together, defendant treated the plaintiff in a cruel and inhuman manner, in that on the 15th day of July, 1935, the defendant in the company of another woman and two men visited a tavern known as the Jail House in the City of Minneapolis and remained there for several hours during which time defendant became very intoxicated and spent Fifteen Dollars of plaintiff' money;

that thereafter and on the 15th day of November, 1935, defendant, over the objections of plaintiff secured a position as waitress in a beer parlor, known as Mickey's Bar and worked there for a period of about four weeks, that during that time defendant remained away from the home of the parties until four or five o'clock in the morning in the company of other men and when she would return she would be very much intoxicated; that during said time the defendant also stayed at the rooming house operated by her father and did on may occasions have men callers at her room some of which stayed wath her all night; that the defendant did on as many as six or seven times come to her father's rooming house in an intoxicated condition with other men; that plaintiff always gave his pay check to defendant and when the defendant left plaintiff in December, 1935, she took all of plaintiff's money amounting in all to \$887.00, no part of which she returned; that during all of said time defendant treated plaintiff with contempt and often said cruel and abusive things about plaintiff in the presence of other people.

The Court finds as:

CONCLUSIONS OF LAW.

1. That plaintiff is entitled to a decree of divorce absolutely dissolving the bonds of matrimony heretofore existing between the plaintiff and defendant.
